Committee on the Rights of the Child

List of issues prior to submission of the combined fifth and six periodic reports of Switzerland*

1. The State party is requested to submit in writing the information requested below (21,200 words maximum), if possible before 15 October 2020. The replies should take into consideration the Committee's recommendations, contained in its previous concluding observations (CRC/C/CHE/CO/2-4 and CRC/C/OPSC/CHE/CO/1) adopted on 30 January 2015. The Committee may take up all aspects of children's rights set out in the Convention and its Optional Protocols during the dialogue with the State party.

I. New developments


- 2. The Committee requests the State party to provide:
- (a) Information on the adoption or reform of laws, policies and programmes, and any other type of measures taken, such as the creation or reform of institutions, significant for the implementation of the Convention and its Optional Protocols on the involvement of children in armed conflict and on the sale of children, child prostitution and child pornography;
- (b) Any other information that the State party considers relevant in this regard and that is not covered in the replies to the questions below, including information on obstacles and challenges faced.
- 3. The Committee also requests the State party to provide information on how the planning, implementation and monitoring of measures for achieving the Sustainable Development Goals integrate a child rights-based approach, including on child participation and data collection, and how they promote the realization of children's rights under the Convention and its Optional Protocols.

II. Rights under the Convention and its Optional Protocols

A. General measures of implementation (arts. 4, 42 and 44 (6))

Reservations

4. Please inform the Committee about the measures taken to withdraw the reservations to articles 10, paragraph 1 regarding family reunification; article 37 (c) requesting that every child deprived of liberty is separated from adults; and article 40, paragraph 2 (b) (ii)-(iii) regarding due process for children in conflict with the law.

Comprehensive policy, strategy and coordination

5. Please provide information on the measures taken to develop and implement, in consultation with children and civil society, a federal policy and strategy for the overall implementation of the Convention, with the aim to provide a coherent national approach and a framework for cantonal plans and strategies. Please also indicate whether all cantons have a child policy and if not please explain why. Please inform the Committee on how the coordinating entities for the implementation of the Federal Act on Promotion of Children and Young People (of 1 January 2013) ensure the coordination of the comprehensive implementation of the Convention.

Data collection

- 6. Please inform the Committee on the measures taken to:
- (a) Collect disaggregated data on the implementation of the Convention, and use that data for the formulation, monitoring and evaluation of policies, programmes and projects for the implementation of children's rights;
- (b) Ensure that data collected is disaggregated for children with disabilities; children in all alternative care settings; asylum-seeking, refugee and migrant children; children *sans-papiers*; domestic and intercountry adoption; and missing children, such as abducted children and children who run away from their family/care situation, including unaccompanied children seeking asylum.

Independent monitoring

7. Please provide information on the establishment of a dedicated body for the independent monitoring of the Convention, and to ensure that it is able to receive, investigate and address complaints by children in a child-sensitive manner, ensure the privacy and protection of child victims, and undertake monitoring and follow-up activities for child victims.

Cooperation with civil society

8. Please inform the Committee about the efforts made to collaborate with civil society, including non-governmental and children's organizations, in the planning, implementation, monitoring and evaluation of laws, policies, plans and programmes related to the implementation of the Convention and its Optional Protocols.

Children's rights and the business sector

9. Please inform the Committee about the results of the report of the Federal Council in response to the von Graffenried proposal 12.3503 "A Ruggie strategy for Switzerland" of 9 December 2016, and the measures taken concerning the establishment of a regulatory framework for industries operating in the State party to ensure that their activities do not negatively affect human rights or endanger environmental, labour and other standards, relating to children's rights; and that business enterprises domiciled, registered or operating in the State party with operations abroad are legally accountable for violations of the rights of the child.

B. General principles (arts. 2, 3, 6 and 12)

Non-discrimination

10. Please provide information on social integration initiatives to eliminate, in practice, discrimination against children in marginalized and disadvantaged situations, namely in accessing education, particularly for children with disabilities, children with a migrant background, refugee and asylum-seeking children, and children *sans-papiers*. Please provide information on the measures taken to eliminate discrimination against lesbian, gay, bisexual, transgender and intersex children, including the adoption of the draft law resulting from the parliamentary initiative Reynard 13.407 "Fight against discrimination based on sexual

orientation" and the results of the report of the Federal Council in response to the proposal Naef 12.3543 "Report on the Right to Protection from Discrimination".

Best interests of the child

11. Please inform the Committee about the measures taken to ensure that the concept of "best interests of the child" is adequately translated in all official languages of the State party, and its legal meaning well understood. Please provide information on the development and dissemination to all relevant professional groups of policy, procedures, criteria and guidance to determine and consistently apply the best interests of the child as a primary consideration in programmes and administrative and judicial proceedings concerning children, in particular regarding parental custody, placement in alternative care and migration and asylum procedures.

Respect for the views of the child

- 12. Please provide information on the requests CSEC-N 14.3382 and Reynard 13.4304, and on:
- (a) The procedures adopted by the judicial and administrative authorities to guarantee the right of the child to be heard in any decision affecting her or him, including child victims, children with disabilities, children in alternative care, and asylum-seeking, refugee and migrant children;
- (b) The efforts taken to ensure that children have the right to express their views freely in all matters affecting them, and have those views given due weight, with particular attention to children in marginalized and disadvantaged situations;
- (c) The measures taken to ensure that professionals in the judicial, welfare and other sectors dealing with children systematically receive appropriate training on how to ensure the meaningful participation of children.

C. Civil rights and freedoms (arts. 7, 8 and 13–17)

Nationality

- 13. Please provide information on the measures the State party has taken to complete ratification of the 1961 Statelessness Convention; to grant Swiss nationality to stateless children living in its territory; and to prevent statelessness and grant Swiss nationality at birth to:
- (a) Children born in its territory, irrespective of the legal status of their parents, if they would otherwise be stateless, including children of refugees, asylum-seekers and migrants without regular residence status;
 - (b) Children born abroad through surrogacy to Swiss nationals.

Right to know and to be cared for by parents and right to identity

- 14. Please inform the Committee about the measures taken to:
- (a) Ensure respect for the right of an adopted child or a child born as a result of medically assisted procreation to know his or her origin;
- (b) Remove the reference to legitimate interest as a precondition for the child's right to request information regarding her or his biological origin;
 - (c) Prohibit the use of baby boxes.

D. Violence against children (arts. 19, 24 (3), 28 (2), 34, 37 (a) and 39)

Freedom of the child from all forms of violence

15. Please provide information on:

- (a) The measures taken to prohibit explicitly all forms of corporal punishment in all settings;
- (b) The systematic collection and analysis of comprehensive data on all cases of violence against children, including maltreatment, child sexual abuse in and outside the home, and domestic violence;
- (c) Studies undertaken to assess the prevalence and nature of violence against children, and development of a comprehensive strategy for prevention and intervention in cases of violence against children;
- (d) The evaluation of the work of existing structures to address violence against children and measures taken to strengthen national coordination to address all forms of violence against children.

Harmful practices

- 16. Please provide information on the measures taken to:
 - (a) Prevent and address female genital mutilation;
- (b) Ensure that intersex children are not subjected to unnecessary medical or surgical treatment and provide adequate counselling, support and access to effective remedies to the victims subjected to such treatment during childhood. Please provide information on whether unnecessary medical or surgical treatment to intersex children are still covered by the disability insurance;
- (c) Support those in situations of child marriage, and in particular the support provided by the Federal Competence Centre for Forced Marriage to the reported 107 children married in 2017.

E. Family environment and alternative care (arts. 5, 9–11, 18 (1) and (2), 20, 21, 25 and 27 (4))

Family environment

17. Please provide information on the preliminary outcomes of the amended Federal Act on financial assistance for extra familial childcare, effective from 1 July 2018 to 30 June 2023. Please inform the Committee of any other measures taken to support families, including extending maternal and paternity leave, and to ensure that both parents, including separated parents, share the responsibilities for the upbringing and development of their children.

Children deprived of a family environment

- 18. Please provide information on the *Casadata* platform and on the measures taken to:
- (a) Ensure that adequate safeguards and clear criteria, based on the best interests of the child, for determining whether a child should be placed in alternative care are applied throughout the territory of the State party;
- (b) Regulate and effectively enforce high-quality standards in alternative care settings throughout the State party's territory to ensure that children receive similar quality care independently of where they live;
 - (c) Promote and support foster families;
- (d) Ensure that alternative care for children under the age of 3 is provided in family care;
- (e) Support parents when children placed in alternative care return to their families.

Adoption

- 19. Please provide information on the work of the interdepartmental working group (DFI and FDJP) and on the measures taken to:
- (a) Ensure that the safeguards provided in the 1993 Hague Convention on Protection of Children and Co-operation in respect of Intercountry Adoption are met, even if the other country is not a party to that Convention;
- (b) Accelerate the 1-year assessment procedure and ensure that a child adopted from abroad, or a child born through international surrogacy arrangements, is not stateless during the waiting period between his or her arrival in the State party and formal adoption.

F. Children with disabilities (art. 23)

- 20. Please provide information on the measures taken to:
- (a) Ensure State-wide inclusive education and provide clear guidance to cantons that still apply a segregated approach;
- (b) Ensure that children with disabilities have access to early childhood education and care, early development programmes and inclusive vocational training opportunities in all cantons;
- (c) Legally prohibit the practice of "packing" children with autism spectrum disorders and eliminate it from the disability insurance coverage, and ensure that children with autism spectrum disorders have access to inclusive education and care;
 - (d) Prevent children with disabilities from being placed in psychiatric units.

G. Basic health and welfare (arts. 6, 18 (3), 24, 26, 27 (1)–(3) and 33)

Health care and health services

- 21. Please inform the Committee about:
- (a) The progress made to ensure access to quality paediatric services throughout the territory of the State party;
 - (b) The health insurance coverage for children with rare diseases;
- (c) The measures taken to address overweight children and obesity, promote a healthy lifestyle among adolescents, including carrying-out physical activities, and reduce food-marketing pressure on children with regard to food high in fat, sugar and salt.

Breastfeeding

- 22. Please inform the Committee on the measures taken to:
 - (a) Develop a comprehensive national strategy on feeding practices for infants;
- (b) Raising awareness concerning the importance of breastfeeding and the risks of formula feeding and ensure that the International Code of Marketing of Breast-milk Substitutes is strictly enforced.

Mental health

- 23. Please provide information on:
 - (a) The Action Plan for Suicide Prevention, adopted in November 2016;
- (b) The findings and recommendations of the study FOKUS; and the measures taken to carry-out research on non-drug approaches to the diagnosis and treatment of behavioural and attention disorders among students;
- (c) Measures taken to support health authorities to better diagnose mental health problems among children;

(d) Support children with mental health problems and their families to psychological counselling and emotional support.

Standard of living

24. Please provide information on the results of the Comprehensive Anti-Poverty Strategy for Switzerland and the National Programme to Prevent and Fight Poverty (2014–2018), in decreasing child poverty throughout the territory, and in particular among asylum-seeking, refugee and migrant children.

Impact of climate change on the rights of the child

- 25. Please provide information on the measures taken to:
- (a) Reduce greenhouse gas emissions by at least 20 per cent by 2020, including in relation to the aviation and transport sector;
- (b) Inform the population about the effect of pollution on children's health and remedial measures;
- (c) Ensure that private and publicly owned financial institutions take into consideration the impact of climate change on the rights of the child of their investments, in particular in the fossil fuel industry.

H. Education, leisure and cultural activities (arts. 28–31)

Early care and education and human rights education

- 26. Please inform the Committee about the measures taken to:
- (a) Ensure access to affordable early childhood education and care to all children, in particular children in disadvantaged socio-economic situations;
- (b) Prevent early school leaving, in particular children in disadvantaged socioeconomic situations;
- (c) Include mandatory modules in the languages of the State party on the Convention and human rights in general in the harmonized school curricula.

Rest, leisure, recreation and cultural and artistic activities

27. Please provide information on the measures taken to provide children with accessible and inclusive sporting, recreational, leisure, cultural and artistic activities, particularly with regard to children with disabilities, asylum seeking and refugee children, children of migrant parents, and children in disadvantaged socio-economic situations.

I. Special protection measures (arts. 22, 30, 32, 33, 35, 36, 37 (b)–(d) and 38–40)

Asylum-seeking, refugee and migrant children

- 28. Please provide information on the measures taken to:
- (a) Establish age determination procedures which respect the privacy and integrity of the child;
- (b) Provide all asylum-seeking, refugee and migrant children with mental health services;
- (c) Ensure that reception centres at the cantonal level conform to minimum standards for reception conditions, integration support and welfare for children;
- (d) Ensure that "persons of trust" working with unaccompanied children are adequately trained both in the legal and the psychosocial field;
 - (e) Exempt unaccompanied children from the accelerated asylum procedure;

(f) Ensure that children under the age of 18 are not detained because of their migration status.

Children without a regular residence status (sans-papiers)

29. Please provide information on the measures taken to ensure that all children *sans-papiers* have effective access to education, health care and welfare services.

Administration of child justice

- 30. Please provide information on the measures taken to:
 - (a) Raise the age of criminal responsibility;
 - (b) Ensure that children have access to free legal counsel;
- (c) Adequately train all persons involved in the administration of child justice, including defence lawyers, on the rights of the child;
 - (d) Ensure that children are not detained with adults.

J. Optional Protocol on the sale of children, child prostitution and child pornography

- 31. Please inform the Committee about the measures taken to implement its previous recommendations under the Optional Protocol (CRC/C/OPSC/CHE/CO/1), including:
- (a) The adoption of a comprehensive policy and strategy to implement the Optional Protocol, including measures for the prevention, protection, physical and psychological recovery and social reintegration of child victims;
- (b) The definition, prohibition and criminalization of sale of children in accordance with article 3 of the Protocol, and of sexual exploitation through the use of information and communication technology, and provide full protection to all children under the age of 18.

K. Optional Protocol on the involvement of children in armed conflict

- 32. Please inform the Committee about the measures taken to implement its previous recommendations under the Optional Protocol (CRC/C/CHE/CO/2-4, para. 71), and in particular:
- (a) The establishment of a mechanism for the early identification of asylumseeking, refugee and migrant children who may have been recruited or used in hostilities abroad;
- (b) The conduct of training programmes for the personnel responsible for the identification and referral of those children to protection services.

C. Civil rights and freedoms (arts. 7, 8 and 13–17)

37. Please provide data, disaggregated as described in paragraph 33 above, on the number of stateless children.

D. Violence against children (arts. 19, 24 (3), 28 (2), 34, 37 (a) and 39)

- 38. Please provide data, disaggregated as described in paragraph 33 above, on:
- (a) The number of cases of violence against children, including corporal punishment, reported to the authorities, investigated and prosecuted, and the sanctions issued to perpetrators, disaggregated by type of offence;
- (b) The number and type of protective measures provided to child victims of violence, and in particular domestic violence.

(d) The number of reported cases of violence, including sexual violence, against children with disabilities, and the number of investigations and prosecutions carried out and sentences issued.

G. Basic health and welfare (arts. 6, 18 (3), 24, 26, 27 (1)–(3) and 33)

- 42. Please provide data, disaggregated as described in paragraph 33 above, on:
- (a) The number and proportion of children with health insurance, including for rare diseases;
- (b) The number of paediatric and mental health services and professionals specialized in young children and adolescents, disaggregated by canton.

- (a) The number of asylum-seeking and refugee children entering the State party from areas in which children have of may have been recruited or used in hostilities;
- (b) The number of children who benefit from physical and psychological recovery and social reintegration measures.
